They will be limited to Dining privileges only. No Parent/Guardian will be permitted to use the Pool or Golf Amenities

For applicants between the age of 24 and 29. Use of all Amenities.

Initiation Fee: \$2,000.00

Food Minimum: \$500.00 (Bi-Annual)

### **Executive**

For applicants over the age of 40. Use of all amenities

Initiation Fee: \$2,000.00

Food Minimum: \$500.00 (Bi-Annual)

### **Senior**

For applicants over the age of 65. Use of all amenities

Initiation fee: \$2,000.00

Food Minimum: \$375.00 (Bi-Annual)

### **Super Senior**

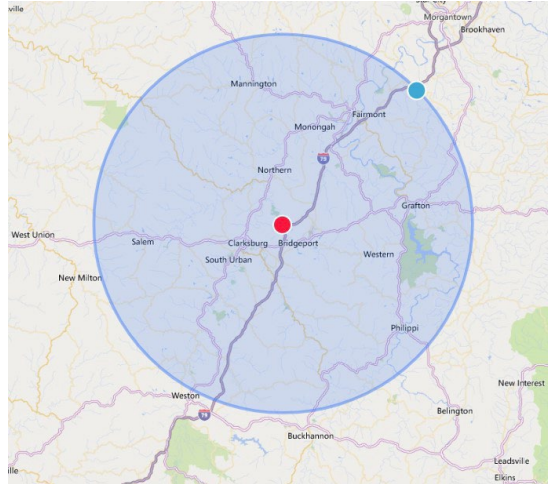
For applicants over the age of 80. Limited to the Member and/or Spouse

## **Social**

Applicants will be allowed use of the dining and limited golf amenities, No Pool. Dining Socials will be allowed 6 Rounds of Golf Yearly and will be required to pay Greens Fee and Cart Fee. Rounds will be counted regardless of 9 holes or 18 holes. Dining Socials will not be permitted to play in any Club Golf Tournaments. Dining Socials will not be allowed to bring Guests to play Golf. Dining Socials golf privileges will be limited to the member and/or their spouse, children will not be allowed to use golf privileges.

## **Swim & Dining Social**

Applicants will be allowed use of the dining and pool amenities only, No Golf. Swim & Dining Socials pool privileges will be limited to the member and/or their spouse only. No Children are permitted to use the pool.

Food Minimum: \$500.00 (Bi-Annual)

### **Golf & Dining Social**

Applicants will be allowed use of the dining and Golf amenities only, No pool. Golf & Dining Socials will be limited to the member and/or their spouse only. No Children are permitted to use the golf course.

Initiation Fee: \$2,000.00

Food Minimum: \$500.00 (Bi-Annual)

### **Corporate**

Minimum of 4 Memberships required to join as a corporation. All applicants must provide a proof of employment under corporation applying for the membership. Any additional memberships will be an additional \$4,322.00/Annually.
